 - c) Attested copies (in duplicate) of all Educational Certificates and Physically Handicapped Certificate etc. claiming reservation. They should also bring with them the Original Certificates for verification at the time of Joining.
 - d) Caste Certificate/ incase of SEBC candidate up-to-date Caste Certificate.
 - e) Permanent address in full.
 - f) Oath of allegiance duly filled in
