Applications are invited for appointment to the posts of whole time Chairperson (one) and Members (two) in the Odisha State Food Commission, set up by Government of Odisha under the provisions of the National Food Security Act, 2013 (NFSA). The Chairperson and Members of the State Food Commission are to perform such duties and functions and exercise such powers as prescribed under the NFSA and Odisha State Food Commission Rules 2016 made there under. The Head Office of the Commission is at Bhubaneswar.

### 2. Scale of pay:

- (i) **Chairperson:** Basic Pay- Rs. 2,25,000/- (Fixed) with usual DA & other allowances fixed by Government from time to time.
- (ii) **Member:** Basic Pay- Rs. 1,82,200/- (Fixed) with usual DA & other allowances fixed by Government from time to time.

(i) The Chairpersons and other members shall be appointed from amongst persons-.

- (a) who are or have been members of the All India Services or any other civil services of the Union or State or holding a civil post under the Union or State having knowledge and experience in matters relating to food security, policy making and administration in the field of agriculture, civil supplies, nutrition, health or in any allied field; or
- (b) of eminence in public life with wide knowledge and experience in agriculture, law, human rights, social service, management, nutrition, health, food policy or public administration; or
- (c) who have a proven record of work relating to the improvement of the food and nutrition rights of the poor.
- 4. Age limit and tenure: The Chairperson or Member, State Food Commission shall hold office for a term not exceeding three years from the date on which he enters upon the office and shall be eligible for re-appointment for a period of one year, provided that no person shall hold office as Chairperson/Member after he has attained the age of sixty-five years. The Chairperson/Member shall not concomitantly hold any other office.
- **5.** The applicants are advised to go through the provisions of National Food Security Act, 2013 and Odisha State Food Commission Rules 2016 and satisfy themselves about their eligibility and other conditions for being appointed as Chairperson/Member as the case may be.
