

Paddy	Common	1550
	Grade A	1590
Jowar	Hybrid	1700
	Maldandi	1725
Bajra	-	1425
Maize	-	1425
Ragi	-	1900

It is requested that wide publicity may be given to the above MSPs fixed by the Department of Agriculture, Cooperation & Farmers Welfare for procurement in KMS 2017-18 so that farmers are well informed about MSP announced in the States concerned and their participation in MSP programme is ensured.


