Commodity (Fair Average Quality)	(Rs. per quintal) MSP
Wheat	1840
Barley	1440
Gram	4620
Masur (Lentil)	4475
Rapeseed/ Mustard	4200
Safflower	4945

2. It is requested that wide publicity may be given to the above MSPs fixed by the Department of Agriculture & Cooperation, GOI for procurement in RMS 2019-20 so that farmers are well informed about MSP announced in the States concerned and their participation in MSP programme is ensured.
