Bids received on line shall be opened at **11.00 Hours on 19/02/2026** in the office of the Superintending Engineer Cuttack (R&B) Division No.I, Cuttack in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
