The **Superintending Engineer, P.H. Division, Bhubaneswar, Odisha** on behalf of Governor of Odisha invites **Percentage Rate Bids** through e-Procurement in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) **Single Cover System from Manufacturers /Authorized Dealers having valid M.V. license** with the Odisha State Government having experience and expertise in execution of **Similar Type of Works** and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN on **“Percentage Rate Basis”** to be eventually drawn up in the standard **P1 Contract Form**. The bid should be submitted on-line in the website [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.

2. Mode of Submission of tender: Tender should be submitted online in [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in)
3. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes / modifications / addendum to DTCN if any.
4. The original documents i.e., Tender Paper Cost, EMD, Affidavits, Undertakings & Certificates as per the Schedules and Annexure of DTCN that have to be uploaded by the bidder in the e-tender website.
5. The cost of the tender paper and EMD should be deposit through e-payment gateway of Govt. of Odisha in designated bank account.

7. **Minimum Eligibility Criteria :-**

- i) Registered Contractors should have successfully Completed & Commissioned Works of similar type valuing not less than 30% of the estimated cost in any one financial year during the last 3 (three) years (Details in DTCN). The firm shall have to submit the performance certificate of completed & commissioned works constructed by them for satisfactory performance from appropriate authority i.e. not below the rank of Executive Engineer / equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
  - ii) The Contractors should have annual financial turnover of not less than 40% of the estimated cost in any one year during last 3 (three) years and the turnover need to be certified by Chartered Accountant. Weightage @ 10% per year shall be given on the annual turnover of the preceding years.
8. The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) days** from the date of opening of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.


