- 9) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class III**.
- 10) **Bids shall be received only "On-line" on or before 17:00 Hours of 26.02.2026.**
- 11) Bids received "on-line" shall be opened at **11:30 Hours on dtd. 27.02.2026** in the office of the **Executive Engineer, R.W Electrical Division, Sambalpur**, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 12) The rates quoted by the Contractor shall be exclusive of G.S.T.
- 13) The bid for the work shall remain open for acceptance for a period of ninety days from the Last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 14) A bidder shall not be permitted to bid for works in the R.W. Electrical. Division, Sambalpur for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted in the rank of Asst. Engineer & above in any Engineering Dept. or in the rank of Under Secretary & above in any Public Works Deptt. Under Govt. of Odisha.
- 15) The contractor has to upload an Affidavit individually for each work regarding correctness of all the document uploaded in the website.
- 16) Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under (vide office memorandum no. 173/W date 03.01.2026 of Govt. of Odisha Works Department) :
 - 16.1 where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.
 - 16.2 where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price;
 - 16.3 where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price:
 - 16.4 The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
 - 16.5 The additional performance security shall be treated as part of the performance security.
 - 16.6 Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security(APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
- 17) **The single tender received in the 1st call shall be cancelled without opening of the bid.**

- 18) The bidder shall transfer online the cost of bid documents as shown in column-4 above through a process as mentioned in DTCN.
- 19) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
- 20) If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
- 21) Any tenderer desires to avail any facility as per certain circular /order of Govt. have to apply for same along with tender paper. Claim at the time of opening of tender or later will not be entertained.
- 22) Authority will not be held responsible for any technical problem/ failure of network, server during the schedule dates of online bidding.
- 23) Conditional tender will be summarily rejected. The Authority reserves the right to reject any or all bids without assigning any reason thereof.
